



## CONTRACT FOR SERVICES

This Agreement, by and between MO BASEBALL ACADEMY LLC (“Coach”) and \_\_\_\_\_ (“CLIENT”) is made this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_. The parties hereby agree that the following terms and conditions shall govern the Coach’s provision for coaching and training services to CLIENT:

1. **Duration.** The Client seeks coaching services for the \_\_\_\_\_ Season. A new Agreement must be executed for each subsequent season.
2. **Fees.** There is a \$45, non-refundable, registration fee per season due upon the signing of this Agreement. A season will last ten weeks; see Addendum A for season schedule. Coach agrees to provide Coaching services to Client in exchange for payment of \$\_\_\_\_\_ per week. Payments shall be made weekly and are due the Friday before Coaching is to begin. The Client may not participate in Coaching services without payment being made. Payment for coaching services is non-refundable.
3. **ATTACHMENT.** Client has read and executed the Full Disclosure of Physical Conditions, Release of Liability and Assumption of Risk, Photo/Video Release, which is attached hereto and incorporated into this agreement as if fully set forth herein.
4. **Services Provided.** Coach agrees to provide Baseball coaching and training services to the Client. These serves may include, but are not limited to:
  - a. Batting
  - b. Pitching
  - c. Fielding
  - d. Strength and Conditioning
  - e. Scouting Opportunities
  - f. Professionalism/DisciplineCoach reserves the right to include additional services or remove services depending on the need of Client and other participants.
5. **Warranties.** There are no warranties either express or implied in this Agreement that are not expressly contained in this Agreement. Coach will make all reasonable efforts to have scouts from Major League Baseball and its affiliates to evaluate players, but in no way guarantees the participation of such. Furthermore, Coach in no way guarantees or warrants to Client that Client will be able to play in Major League Baseball, its affiliates, or any similar program.

6. **ENTIRE AGREEMENT.** This Agreement (including the Full Disclosure of Physical Conditions, Release of Liability and Assumption of Risk, Photo/Video Release) constitutes the entire agreement of the Parties, and supersedes any and all previous understanding, agreements, arrangements, or discussions, written or oral, between the Parties relating hereto. There are no collateral agreements, representations, or guarantees, oral or otherwise unless attached hereto and signed by both Parties.
7. **SEVERABILITY.** If any term, covenant, condition, or provision of this agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of the provisions shall remain in full force and effect and shall in no way be affected, impaired or invalidated.
8. **CHOICE OF LAW AND VENUE.** This Agreement shall be governed by the laws of the State of Florida. Any claim or dispute that may arise out of this contract shall be resolved by a court in Pasco County, Florida. You agree to submit to the personal jurisdiction of the courts located within Pasco County, Florida for the purpose of litigating all such claims or disputes.
